## BANKSIA VILLAGES MEMBERSHIP

In line with the Corporations Act 2001 and Banksia's Constitution, the company has members who play an important role in the structure of the company and enjoy rewarding members-only benefits.

### Member benefits

Depending on their category of membership, members enjoy a range of benefits including attendance at company meetings, voting rights, eligibility for election as a Director, invitations to special events and activities, participation in volunteer programs, annual financial statements and company performance reports, and regular updates. Members are also eligible to be elected to Life Membership, in recognition of distinguished service or contribution.

The greatest benefit of membership, though, is being part of an active and engaged community committed to further developing Banksia's services and support for older people and others needing care and support throughout our region.

### Eligibility

Members must be at least 18 years old whose nomination has been approved by Banksia's Board of Directors. Current Banksia residents and clients on Banksia's Wait/Hot List may apply for Associate membership. Previous employees can apply for Full or Associate membership 12 months after leaving their employment. All members agree to be bound by Banksia's Constitution and policies.
